## **Description**

Introduce yourself to ways of using the English language in the legal profession. Equip yourself with a basic understanding of the professions and corresponding duties to be found within the law, the terminology and language structures used in legal proceedings or documents such as contracts, agreements, and legal opinions. Begin to familiarise yourself with the characteristics of 'legalese' and terms related to the parties involved and types of litigation that can be brought against businesses. Engage in discussions about the merits of newsworthy court cases. Touch on the career skills of negotiation and bargaining and take every opportunity to try out new techniques and conversational moves to achieve your goals.

- Learn how to express definite opinions when you take a stance and balanced opinions when undecided
- Act as a judge for a set of real cases and decide whether to award compensation or to dismiss the case
- Negotiate a new rental contract with conditions
- Represent a cosmetics company about to be involved in legal action against another with the same brand name in a roleplayed negotiation
- Prepare objectives and decide on concessions before negotiating
- Participate in a moot court

#### **LISTENING**

Get key information from three dialogues involving negotiation and mine for useful phrases corresponding to negotiating strategies

### **READING**

- Understand textual structure and the content of paragraphs to scan efficiently for specific information
- Grasp gist, nuance, and the author's position

### **VOCABULARY & ACCURACY**

- Complete a short article about Hollywood representations of the legal profession with legal jargon, verb-noun partnerships, and passive forms
